17. Rates and Charges - TDS Telecom Companies-Group B¹

If the aggregate level of demand for switched access local switching minutes of use experienced by the TDS Telecom Companies-Group B whose rates and charges are contained in this tariff section in any month exceeds a 100 percent increase in the interstate local switching demand over the same month in the previous year (refile trigger), the TDS Telecom Companies-Group B will file revised local switching and tandem switched transport tariff rates within 60 days of the end of the month in which the issuing carrier met the refile trigger.
