Unless otherwise indicated in the tariff schedules of the Utility, the use of the service is restricted to the customer, their agents and representatives and no service, furnished under the Rules contained in the tariff schedules, shall in any case be resold. This prohibition shall not apply to a composite data service vendor in the provision of composite data service to its patrons, to a communications common carrier in the provision of public telegram message service or overseas data message service, or to hotel-motel service customers. Flat Rate Exchange Service is not installed on premises of a public or semi-public character in a location where the telephone would be accessible for use by the patrons of the customer or the public in general.

If it is found that the customer is sharing the use of their business service with an individual or concern, other than an employee, member, or officer of the customer's concern or of a "joint user," the Utility will require the customer to take "joint user" service except where the customer permits no further joint use of the service after the matter has been called to their attention or where the joint user vacates the customer's premises or becomes a business service customer in the same exchange.
