RADIO PAGING SERVICE

P.2 Radio Paging Service

P.2.1 General

Radio Paging Service will allow the subscriber of this service to receive a one-way radio signal that activates a unique pager when an assigned conventional seven digit telephone number is dialed. It may be offered as "tone only" or "tone and voice".

P.2.2 Definitions

Tone only. A class of paging service that alerts the subscriber of a page by a moderately loud "beeping" tone.

Tone and voice. Similar to "tone only" service with the addition of a fixed "on the air" time to allow the calling party to deliver a verbal message. The time allowed for such a message may vary from 10 to 20 seconds.

Pager. Also referred to as "beepers", a pager is a small battery operated radio receiver usually carried by the subscriber. The pager is an item which may be owned by the subscriber.

Paging number. The seven digit telephone number assigned to a given pager.

P.2.3 Rates

a. Radio Paging Service

P.2.4 Conditions

a. Radio Paging Service is offered subject to all regulations of this Tariff, except as specifically modified in this Section.

b. Radio Paging Service is furnished through dial switching equipment and a land radio telephone station to a paging receiver equipped for such service.

c. Radio Paging Service is not offered on a Company wide basis. The service is offered in only those areas deemed by the Company to be satisfactory and where facilities are available.

RADIO PAGING SERVICE

P.2.4 Conditions (continued)

- d. Due to inconsistencies of high frequency radio propagation, communications may be unobtainable in some areas, even though surrounded by strong signal locations. In no event shall the Company be liable for any damages of any kind or nature in connection with or arising from the existence, furnishing, functioning, or customer's use of any services provided.
- e. Paging receivers must be provided by the customer. The Company shall determine if such customer provided equipment is suitable for the proper operation of the service.
- f. The subscriber assumes all responsibility for all applicable service charges.  
(See Section D for applicable Element Service Charges).
- g. The initial contract period for Radio Paging Service is 30 days. Service may be terminated by the subscriber after the initial contract period subject to payment of all applicable charges.
