FOREIGN EXCHANGE SERVICE ¹

(C)

GENERAL

1. Foreign Exchange Service is exchange service furnished from an exchange other than that normally serving the area in which the customer is located. When there is a customer requirement, and suitable facilities are available, this service may be extended to include a third exchange.
2. This service is intended only for communications in which the customers or joint users as arranged for, have a direct interest and shall not be used for any purpose for which a payment or other compensation shall be received by him or by joint user, from any other person, firm or corporation for such use, or in the collection, transmission or delivery of any communications for others.
3. Foreign Exchange Service is furnished on an unlimited basis in accordance with services offered in the exchange of connection.
4. Municipal Calling Service is not furnished with Foreign Exchange Service unless dial tone is provided from a Central Office service some portion of the municipality in which the Foreign Exchange line service address is located.
5. Foreign Exchange Service furnished in connection with Centrex Systems is subject to the regulations specified in Section 3 of the regulated local tariff.

RATES AND CHARGES

1. Exchange Service

The rate of foreign exchange service is the rate in effect in the Foreign Exchange for the Class of Service furnished. In addition, tariff rates and charges apply for extension telephone service or for terminations in equipment, such as key telephone systems, at the customer premises.

2. Channels

- a. Interexchange channels, measured between the rate centers, per airline mile is \$6.00.
- b. When a foreign exchange channel is extended to a third exchange, the mileage measurement is that combination of two-point mileage connecting the rate centers which will produce the lowest interexchange mileage charge.

PRIVATE LINE SERVICE (Interexchange)

(C)

General Description

Interexchange Private Line Services (PLS) is telecommunications service between two or more termination points within the LATA where one termination point is located within the Company's local exchange area and the other termination point is located in another local exchange area. PLS is not connected to, or otherwise made available to, any local exchange switching facility.

Interexchange Services

1. Concurrence Statement

The Company concurs in its interstate special access service tariff for terms and conditions, together with any amendments and successive issues, for the purpose of providing interexchange private line services and channels.

This concurrence is limited to services that are at or below a speed of 44.736 Mbps. Any service requiring speeds above 44.736 Mbps will be provided on an ICB basis.

The Company hereby expressly reserves the right to cancel this statement of concurrence at any time when it appears that such cancellation is in the best interest of the company.

Requests for Private Line Services will be furnished subject to the availability of central office equipment and appropriate outside plant facilities.
