18. LONG DISTANCE MESSAGE TELECOMMUNICATIONS SERVICE

APPROVED

18.1 General

This tariff is applicable to intrastate long distance message telecommunications service furnished or made available by Williston Telephone Company, Inc., hereinafter referred to as the Company.

18.2 Concurrence

This Company concurs in the rates and charges governing message toll telephone service as filed by the Southern Bell Telephone and Telegraph Company (South Carolina) with the Public Service Commission of South Carolina. Any amendments thereto or successive issues thereof are hereby adopted and made part of this Tariff, with the provision that this Company reserves the right to cancel this concurrence after compliance with requirements as to tariff filings as may be necessary upon such cancellation. Exceptions to this concurrence are listed below:

A. Exceptions

- 1. Direct Dialed Calling. Direct Dialed calls are considered a part of the South Carolina LATA-wide Area Calling Plan, as specified in Section 3.7 of this tariff. Customers who do not subscribe to one of these Plans, including the Saver Service plan, will default to the residence plan described under Section 3.7.C.3 and business plan described under Section 3.7.D.1 of this tariff.
- 2. Direct Dialed Directory Assistance and Toll Directory Assistance Call Completion Services. (N)
